# Monthly, Annual, or Life Membership?

I was recently browsing through a member publication of a local private club and noticing the various activities offered to their members and reports of the various groups within the club. I found myself asking why this organization was considered successful and why so many members paid over \$1,000 a year just to belong. I naturally began comparing the benefits of membership in this club versus our own fraternity.



Many of the activities offered were the same – New year's dinner dance, ladies luncheons, golf outings, opportunities to bring family and friends to events and share fellowship with other members and their families. Certainly the club facility is a beautiful, historic building in a great downtown location, but few structures anywhere can be favorably compared to the Scottish Rite Cathedral in its

uniqueness, grandeur and beauty. Members and guests attending events at the club were charged for their participation to defray the costs of the function. Scottish Rite members can come to many events at the Cathedral that are free of charge or cost a nominal amount such as \$5 for a show or \$12 for a complete meal and entertainment at the Father/Daughter, Mother/Daughter or Father/Son Banquet. In addition Scottish Rite members enjoy fine community theater in our auditorium at no cost to the member or his guest. Local Scottish Rite clubs also provide an outreach to our Brethren distant from Indianapolis.


But beyond the activities offered, what of the programs available to those not able to attend functions regularly? Each year the Valley of Indianapolis provides college scholarships to children of members in their Junior or Senior years of college. This program, in combination with the Grand Lodge Scholarship program, provides financial benefits to our families. Our charities are extensive. Just paying dues and supporting the work of Scottish Rite allows us to operate the 32<sup>nd</sup> Degree Masonic Learning Center for Children in Indianapolis which helps countless children with dyslexia through free of charge individual tutoring. The Scottish Rite of Indianapolis Foundation, Inc. provides grants to

community and Masonic organizations of over \$150,000 per year.

The *annual* dues I pay to maintain my symbolic lodge and Scottish Rite membership is approximately what *one month* costs at the private club. Further, the *annual* dues to the club would pay for a *life membership* in the Scottish Rite. When you equate funds expended to benefits received – can there be any doubt that the Masonic Fraternity represents a terrific value?

Further, your membership benefits our society in general in a much larger way. You are part of a worldwide fraternity that teaches to its members and all the world that moral virtues are important, that spiritual growth is essential to living a full life, that respect for individuals, families and your country is important to you receiving the same respect.

utoring at the 32° Masonic Learning Center is free. That is a wonderful opportunity for the nearly fifty dyslexic children attending twice a week, thirty two weeks a year. However free does not mean easy. Students give up two afternoons a week not only for the 50 minute tutoring session, but for the often hour long drive in each direction. Parents also give up these six hours a week to be sure their children are getting this wonderful intervention. With the exception of the unavoidable absences due to illness, most students have nearly perfect attendance. Children arrive each evening enthusiastic and ready to work. The progress they make, nearly all of the children leave the Center reading at or above their

grade level, is testimony to their dedication. The consistent attendance is testimony to the great value these children and their families place on the work of the Center.

utor training is also free at the Center. This value is also recognized by the dedicated tutors who participate in the training offered at the Center. Tutors seeking certification from the Scottish Rite have to commit to nearly a year of supervised training. with no financial compensation. Most of these trainees, currently there are 12, are full time teachers with families. They tutor two students a week and additionally have supervision time with a Master Teacher. Of course they have four lesson plans to write as well. This summer Butler University will also recognize the dedication that goes into this professional development

# Closed for Inventory

Icoholics need to stay away from bars. Bookaholic need to stay away from bookstores. It's dangerous for me to spend time in a bookstore, especially a Christian bookstore. Now my



son was home from college not long ago and both enjoy going. I usually head for the books; he heads for the music. But I said, "Hey, Brad, you want to go down to the

Christian bookstore?". Suddenly, it hit me what time of year it was, and I thought, uh-oh wait a minute, maybe we can't go. Isn't inventory time sometime around now? See, if so, my wallet would be safe this time. Cause inventory means that everything is shut down to take stock.

Well, I'm Ron Hutchcraft, and I want to have "A Word With You" today about "Closed for Inventory".

There was one man in history who was known as the man



after God's own heart by God was David. It is this man whose personal spiritual diary is in your possession. It's called the book of Psalms. One of those is in Psalm 42, it's a real look inside David's

heart. Then comes his question that I hope will become your question. Our word for today from the Word of God is Psalm 42 beginning at verse 1, "As the deer pants for streams of water, so my soul pants for you, O God. My soul thirsts for

God, for the living God."

Here's the question, "When can I go and meet with God?".

Now what's David's frame of mind in this Psalm? Well he says in verse 3, "My tears have been my food day and night". He later describes himself as being downcast, disturbed. In a word David is struggling here. He says something's not right, but instead of sinking he knows where to turn. He says this in the Psalm, "My soul is downcast within me; therefore I will remember you".

e says its time to close the store and meet with God. It might be that time for you too. Time to close for inventory. We



can only go so long without a time away from all the other voices. Life just starts spinning out of control without a periodic time of uninterrupted inventory with God. Stores know you can't really take stock of what you got while you're still selling and servicing customers. They have to lock the doors. They have to hang out a closed sign to do it. It's the same spiritually and emotionally. It's hard to really see where you are and where God wants you to be while you're still meeting all the demands of your daily responsibilities, while you're still servicing all the customers in your life. There must be those times when you hang out the closed

sign and spend some extended time with your Lord.

"When can I go and meet with God" - It might be a day; it might be a couple of days or once in awhile a longer

period of time. You take you, your bible and a big notepad to write down what comes to you



while you're listening to the Lord and expect to fill that pad. This is one of the greatest gifts you can give to your spouse. Taking over their responsibilities so they can close for inventory. It's really a gift to you too. You get a better husband or wife out of it. A son or daughter can offer extra help so their mom or dad could spend this time. A church or a ministry is wise to allow or to encourage their leaders to take an inventory timeout. When you do go meet with God, open up every corner to His search light. Deal with wrong actions and attitudes that have developed.

#### Ritual vs. Idealism: We Must Pay Attention to Both

On a number of occasions, I have written about declining membership in the Masonic fraternity. Each time, I have tried to define the problem and offer suggestions for solutions. This is another attempt in that series.

e have two major categories of members -- I will designate them Category I and II. In Cat I, we have those who participate in the activities of the organization. These members include those who get pleasure from the ritual, participate in the dramatic presentations, enjoy the fellowship of others who attend, and find the activities of the organization fulfilling. In Cat II, we have those who do not attend but continue their membership because they believe in the cause, value the charities, and/or feel pleased and proud to belong to an organization that promotes ethics and morals. Obviously, there are some members who belong to both.

Most people agree that Cat I contains only a small percentage, perhaps one to five percent, of all members of Masonic organizations. Many studies both within and without the fraternity

have shown that fewer and fewer adults wish to participate in organizations like the Masonic fraternity. Therefore, there is little chance that the fraternity's membership will increase as the result of potential members who join in order to participate.

Our charities must be relevant, our cause must be clearly explained...

f membership is to increase, it will be neccessary to find candidates that join for the reasons listed in Cat II. Since Cat II members do not join because of the ritual, the activities, and the fellowship, we must focus our membership efforts with them on our charities, the cause that we represent, and the pride that they feel in belonging to an organization that promotes ethics and morals.

Our charities must be relevant, our cause must be clearly explained, and we must point out that civilization for them, their children, and future generations depends upon strengthening the ethical and moral conduct of individuals and especially individuals in positions of leadership in our society and throughout the world. Freemasonry has the potential to accomplish this

goal. People may ask why this mission is not left to the churches. The answer is that religion tends to be divisive even though most religions recognize the importance of basic ethics and morals. Therefore, inclusive organizations such as the Masonic fraternity have the best opportunity for promoting ethics and morals on a worldwide basis.

hy do we not focus on recruit ing Cat II prospects? By its very nature, the leadership of our fraternity is drawn from Cat I individuals. These individuals see ritual as important in and of itself as well as for the message that it provides. They have enjoyed ritual, they feel that ritual

has benefited them, and they believe that everyone would profit from a similar experience. They enjoy the fellowship that comes from attending regular lodge meetings. They participate in the activities that are provided. In short, they believe that all candidates would benefit from similar experiences. In the thinking of Cat I individuals, it follows that those who

do not enjoy participation will receive little or no benefit from membership. Therefore, they limit their invitations to the fraternity to potential candidates in their circle of acquaintances that would benefit from participation.

Cat I type leadership has additional implications for present members and potential candidates. In order

to enroll many Cat II prospects, we must appeal to their interests. Since they have little or no interest in ritual or participation, we need to reduce these requirements and/or expectations for membership if we wish to attract them to our organization. However, because the Cat I individuals control the organization, they are reluctant to reduce the ritual requirements and participation

expectations. Category I leadership affects Cat II members as well as potential members. Since Cat II members do not participate, they need to have their reasons for membership reinforced, and this requires good communication with them. Since Cat I members get their reinforcement from ritual and participation, they place very little emphasis on the priority of communi-

cation with Cat II members. Lack of communication with Cat II members leads to a large number of demits in this group.


Until we have leadership that understands the needs of Cat II individuals and makes our fraternity appealing to them, we will not be able to attract or retain a high percentage of those in this category. Until we focus on reinforcing the reasons for membership with Cat II members, we will continue to be plagued by a large number of demits. Since Cat II individuals make up as much as 95% of the present and potential members, by not focusing our membership efforts on them, we are missing a huge opportunity to dramatically increase our membership and retain these members.



There is a top-rated show on CBS called CSI which is all about a Las Vegas Crime Lab using forensic evidence to discover the perpetrator of a crime -- usually a murder. The show opens with a theme song by a great rock group, The Who. Coincidentally, the name of the song is "Who Are You?"

As Masons, we are often asked this, yet how do we respond? In my 10 years as a Mason, I have heard a lot of answers and I myself tend to fumble the ball on the goal line . . . so I would like to talk a little about **Mission Statements** -- who we are and what we stand for.

Many, many companies and organizations have developed mission statements over the years. A Google search on the internet provided over 3.5 million hits. Oddly enough, it seems that there are more mission statements for colleges and universities than any other type of organization. Here are some interesting ones: The University of Tennessee's Dept of Athletics...seeks to enhance athletic competition, foster pursuit of academic excellence..and be a source of pride...to students, alumni/ae and supporters. Ben & Jerry's (ice cream) is dedicated to make, distribute, and sell the finest quality natural ice cream in a wide variety of innovative flavors made from Vermont dairy products. The mission of the South Carolina Highway Patrol is to provide equitable service and protection...in order to promote a safe and secure environment for the

public. The Akron Zoo: As conservators of wildlife, our purpose is to provide an enlightening and affordable animal experience that is fun for the families of our community. How about the Masons?

By adding the word "masonic" to the search I narrowed the field down to 9,220 hits. I couldn't discern whose website this was from: The mission of

Freemasonry is to promote a way of life that binds like minded men in a world-wide

brotherhood that transcends all religious, ethnic, cultural, social and educational difference; by teaching the great principles of Brotherly Love, Relief, and Truth; and, by the outward expression of these, through its fellowship, its compassion, and its concern, to find ways in which to serve God, family, country, neighbours and self." A mouthful, but complete; however, as Clara of the Wendy's commercial said, "Where's the beef?"

When somebody asks a Mason, "Who Are You?" how do we reply? We need to develop a Mission Statement that can easily roll off the tongue of any Mason and be succinct, understandable, and motivational to the asker. So how about it? "Who Are You?"

E-mail me your suggestions and let's together develop a response that can be verbalized by every Mason throughout the land when they are asked, "Who Are You? I really wanna know. Tell me, who are you?"
