Hugh Burns Retires as the Valley's Dramatic Director of 12 Years

Every year as spring rolls into Indiana, the Valley officers prepare to advance members in their progressive lines, appoint new men to their lines, and say goodbye to those who have completed their terms of office. This year, the Indianapolis Valley has the highest turnover in recent memory as the headline on the cover suggests: Our Perfect Storm. But after the dust settles, and a new day dawns following upheaval, many times the community is strengthened just by going through the process. And so it is in Indianapolis.

This year, we will lose our Trustee Chair, our Treasurer, and four Presiding Officers and replace them with men who have displayed potential to learn our Craft and help propel our Valley farther into the 21st century. However, we have one more loss and replacement this year: our Dramatic Director for the past dozen years is retiring.

Illustrious W Hugh Burns, 33°, has served the Valley in this role with distinction since 2006 after succeeding Illustrious Bill Woodruff, 33°. During the past 12 years, Hugh has served 36 Presiding Officers and two Executive Directors of the Valley. He has selected titles for 16 membership plays and eight murder mystery plays. He has coordinated the efforts to produce degrees for portrayal after 33 Stated Meetings. Hugh has helped identify members to fill many many roles on stage over the years like stage managers, degree directors, wardrobe and makeup departments, stage crew, and hundreds of individual roles for 24 convocations.

Hugh also was charged with coordinating our road shows over the years. It's not an easy task to load up all of our props, costumes, men, and sometimes food, and transport them across central Indiana on a Saturday morning, yet Hugh almost gives it a whimsical shrug while saying, "It's all of what the best Valley in the world does to get the job done." And yet he did it 21 times.

Hugh also worked closely with Supreme Council when the Valley was asked to cast and provide set locations for filming and producing six videos that are now shown regularly throughout the 101 Valleys and 15 states of the Northern Masonic Jurisdiction. He brushes aside questions when asked how hard it was to coordinate with people outside of Indianapolis. "Just give me Paul Page producing and directing every video degree and it will be done on time, under budget, and with the least amount of problems."

Hugh was recently recognized at the annual Officer Recognition Dinner and in his usual manner, he had little to say about his efforts except that he has found the job immensely rewarding and gratifying.

Past Presiding Officer Steve Taylor has been named to succeed Hugh and will immediately be thrown into the trial-by-fire nature of the job as he is tasked with casting the 32nd Degree that will be conferred in Indianapolis this November. What makes this degree challenging is that the Deputy for Indiana has determined that the only time the 32nd Degree will be conferred in Indiana this year for all five Valleys will be in Indianapolis and with an "all-star" cast assembled from all of the Valleys. Ponder those logistics, if you will.

In Hugh's usual manner, both men shrug it off knowing that their Brothers will step up and find a way to make this happen and pull it off in great form -- to the enjoyment of the candidates and the amazement of those of us who have performed in and directed a few of these ourselves. But that is another chapter to be written. There have been a few of us who, when the caller ID announced that Hugh was calling, knew that an opportunity was about to be offered by this dedicated and humble man that couldn't be turned down.

We were put off, however, by the sales rep who decided that he would not let us leave the lot until we purchased a new car from him. His lack of professionalism and respect for our time was annoying, but since we

had found a model we liked, we decided to proceed with the negotiation process despite our negative impression of our sales rep. When it became apparent that we were not going to get the deal we had hoped for, we politely thanked the rep for his time and headed for the door. That's when the situation deteriorated further. The rep followed us out the door to our car, talking incessantly and warning us that we wouldn't get a better deal anywhere else. By this time, I was really annoyed. I felt myself stiffening up and ready to release a verbal tidal wave, but I was able to control myself. That's when the sales rep noticed our personalized license plate. In one final bit of miscalculated strategy, he said, "INDIANA ... do you work for state govern-

ment or something?" "NO!" I responded tersely. "Oh" he replied. "I thought you were somebody important!" That did it. Trying my best to subdue my passions, I said, "Sir, we ARE important. 


To highlight this, there were three speakers who spoke fittingly about the Tea. The first was Indiana Senator Rod Bray, from Martinsville, who worked in this last session to help pass important dyslexia legislation.

Also Josh Clemens, who suffered from dyslexia, spoke about the importance of adequate ways to address the problem. He successfully completed high school and is now studying at college.

Erin Groce was also present with the sign she made famous in the Indiana State House. These speakers helped remind

everyone of the importance of the work done at the Center. All attendees left with a better appreciation of the work we do and the tremendous support we receive from the Indianapolis Valley of the Scottish Rite.

The State of Indiana recently enacted legislation that will have an important impact on students in Indiana schools. The Children's Dyslexia Center at the Scottish Rite in Indianapolis has been active in advocating for children who suffer with dyslexia and it was proud to be represented at the bill signing in Indianapolis.



This new law will help schools identify students who need dyslexia intervention and will help students receive help at the earliest possible time. The bill, passed by the legislature and signed into law by the governor, requires reading plans for students in grades K-2 and screening, with parental consent, for dyslexia risk factors.

Members of our Board of Governors were active working with the legislature to craft this important legislation. Cheryl Clemens has long advocated for children's issues and was instrumental in speaking with legislators and providing them with research data to support the need for this new policy. Representative and Illustrious Brother Woody Burton, 33rd, helped usher the bill through the Indiana House of Representatives and was able to obtain widespread support from members of both political parties.



Cheryl and Woody, along with Deputy Grand Master Carl Culmann, Director Julie Bohanon, and Board Chair Jim Keating, attended the bill signing at the State House.

The Fantastic Tale of George Gardiner

The virtue of charity is a central tenet of Freemasonry. The fraternity and its members have a long and storied history of charitable giving that has aided those in need. The organization has also attracted the attention of those who wish to impose upon Masonic generosity. In this letter from the collection of the Scottish Rite Masonic Museum & Library, George A Gardiner, most likely a confidence man, requests the assistance of Columbian Lodge, located in Boston, Massachusetts.

To the Officers and Members of Columbian Lodge.

Having lost our property by the great Earthquake of the 26th of March 1812 in Caracas, in South America, and the greatest part of the time since that period been detained by the Spaniards as prisoners, and for the last four years suffered everything but death and frequently threatened with that, and ultimately,— during the contentions in that country, the Royalists having found themselves likely to be overcome by the patriots, Robbed us of everything we possessed even to our clothes, and said “if the patriots should gain the place they would put me, my wife, and my two infant children to immediate and instant Death!”


Anticipating the success of the patriots we resolved to make an effort towards our escape, which we effected the same night, and arrived in Puerto Rico, where we found a friend who gave us passage to this place, where we are in the greatest possible distress, having a sick child and not wherewith to provide for it. The above facts compel me thou’ not without that diffidence and reluctance which every man of spirit must feel on such an occasion to ask from the fraternity a donation for the present and immediate relief of a distressed family who have never before known want.

G.A. Gardiner

In 1820, only two years after writing the above letter to Columbian Lodge, Gardiner published his only known literary attempt, *A Brief and Correct Account of an Earthquake Which Happened in South America*, an account of the 1812 Venezuela earthquake. In addition to incorrectly dating the event—Gardiner stated the earthquake took place on March 26, 1818—he greatly exaggerated the numbers of casualties. His tall tale

included a fantastic description of a “subterranean channel” that “was formed by the tops of two very high mountains falling together” nearly 400 miles from Caracas.

Gardiner's surreal description of Venezuela drew the attention of respected Venezuelan geologist Franco Urbani Patat in 1985. Urbani Patat debunked Gardiner's work, calling it a fictitious invention possibly used to impress others. Gardiner's account amounted to literary fraud, Urbani Patat concluded.



It is unclear why Gardiner, who does not appear to have been a Mason, requested aid from Columbian Lodge or if he made the same request to other Lodges. Furthermore, we may never know for certain whether Columbian Lodge ever responded to Gardiner's plea for assistance. The Museum's collection of records for Columbian Lodge is incomplete and contains several gaps that prevent this question from being answered. That said, research into Gardiner's life provides a better, if not always clearer, picture of the man and of his life.

George A Gardiner was born in New York around 1786 and married Mary Anne Headley of New Jersey sometime before 1818. The couple had at least three children together—a son

George A, born in 1818, a son John Charles, who often used the name Carlos or John Carlos, born in Havana, Cuba, in 1824, and a daughter whose name and birth record have not yet been located. While no record of George A Gardiner's death was found in Ancestry.com, courtroom testimony from the trial of his two sons for perjury and fraud, the infamous Gardiner trial, reveals that senior Gardiner died in Havana, Cuba, possibly around 1840.

As I began this article talking about Tom and Bill and what they did to identify new members and inspire us to consider how we can further serve the Valley (and in the time being, make ourselves better men and Masons), I came to the realization that after a quarter century in the fraternity, and now that Tom and Bill -- and others -- are gone, it is now my great opportunity and solemn responsibility to be 'Tom' and 'Bill' and carry on the mantel of promoter and encourager of our Craft by remembering the motto of the 33rd Degree: "First to the front, last to retreat."
